ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and net proceeds from the Share Offer

The Offer Price has been determined at HK\$0.50 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

Based on the Offer Price of HK\$0.50 per Offer Share, the amount of net proceeds to be received by the Company from the Share Offer, after deducting the underwriting fees and estimated expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$72.7 million. The Company intends to use the entire net proceeds from the Share Offer in the manner set out in the paragraph headed “Offer Price and net proceeds from the Share Offer” below in this announcement and the section headed “Future Plans and Use of Proceeds” in the Prospectus.

Applications under the Public Offer

The Offer Shares initially offered under the Public Offer have been very significantly over-subscribed.

A total of 15,703 valid applications under the Public Offer on **WHITE** and **YELLOW** Application Forms and by **electronic application instructions** given to HKSCC via CCASS have been received for a total of 11,015,910,000 Public Offer Shares, representing approximately 550.80 times of the total number of 20,000,000 Public Offer Shares initially available for subscription under the Public Offer.

Due to the very significantly over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure and Conditions of the Share Offer — the Public Offer — Reallocation” in the Prospectus have been applied. As the number of Offer Shares validly applied for under the Public Offer represents more than 100 times of the number of the Public Offer Shares initially available under the Public Offer, a total number of 80,000,000 Placing Shares have been re-allocated to the Public Offer, so that the total number of Offer Shares available under the Public Offer has been increased to 100,000,000 Offer Shares, representing 50% of the total number of the Offer Shares initially available under the Share Offer.

The Placing

The Offer Shares initially offered under the Placing have been moderately over-subscribed. Following the reallocation described above, the final number of Offer Shares allocated to the places under the Placing is 100,000,000 Offer Shares, representing 50% of the total number of Offer Shares available under the Share Offer. There are a total of 225 places. A total of 78 places have been allotted 10 board lots of Offer Shares or below, representing approximately 34.67% of the total number of places under the Placing. A total of 2,235,000 Offer Shares have been allotted to these places, representing approximately 2.24% of the Placing Shares after reallocation.

The Directors confirm that, to the best of their knowledge and belief, no Offer Shares have been allocated to applicants who are: (i) Directors or existing beneficial owners of the Shares and/or any of the Company's subsidiaries; or (ii) core connected persons (as defined under the Listing Rules) of the Company; or (iii) the respective close associates (as defined under the Listing Rules) of (i) and/or (ii) above (whether in their own names or through nominees). 14,909 valid applications for a total of 3,274,910,000 Public Offer Shares were received for the Public Offer with an aggregate subscription price of HK\$5 million or less based on the maximum Offer Price of HK\$0.60 per Offer Share (excluding the brokerage, the Stock Exchange trading fee and SFC transaction levy payable thereon), representing approximately 327.49 times of the total number of 10,000,000 Public Offer Shares initially available for allocation in pool A.

794 valid applications for a total of 7,741,000,000 Public Offer Shares were received for the Public Offer with an aggregate subscription price of more than HK\$5 million based on the maximum Offer Price of HK\$0.60 per Offer Share (excluding the brokerage, the Stock Exchange trading fee and SFC transaction levy payable thereon), representing approximately 774.1 times of the total number of 10,000,000 Public Offer Shares initially available for allocation in pool B.
